

## MasterCard Debit Card Promotion Terms

### **Giveaway Administration**

This sweepstakes is being administered by Canvas Credit Union.

### **How to Enter**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.**

There are two ways to enter:

1. Conduct eligible transactions with a Canvas debit card between November 1, 2019 and March 31, 2020. Eligible transactions include debit card purchases but exclude ATM transactions. Based on your number of debit card transactions, you will receive a single entry into one prize tier. No one will have an increased chance of receiving a prize by making multiple or duplicate purchases or payments, or by entering more than one time.
2. Mail your name, address, and phone number to Canvas Credit Union, Attn: Marketing Department, P.O. Box 5238, Greenwood, CO 80155. Only one entry per person via mail. Each mailed entry will receive one entry into each tier.

### **Eligibility**

You must be a Canvas member in good standing (i.e. no delinquent loans or shares). Void where prohibited by law. Employees of Canvas Credit Union and its partners, affiliates, and agents are not eligible to participate.

### **Prizes**

There are weekly winners, monthly winners, and a grand prize winner. Value of prizes ranges from \$200 to \$30,000. In lieu of purchase reimbursements, a winner may opt for a cash prize, which may range in value from \$200 to \$10,000. In the event that the grand prize winner has less than \$30,000 of debit card transactions to reimburse, all debit card transactions will be reimbursed for the grand prize winner and the remaining funds will then be used to reimburse an additional winner in a similar manner until all prize funds have been exhausted.

### **General Conditions**

Winners will be notified on a rolling basis beginning on or about November 12, 2019. Canvas Credit Union is not responsible for and shall not be liable for unsuccessful efforts to notify winner; winner may be given up to 5 business days to claim a prize. Participants agree not to hold Canvas Credit Union, its employees or affiliates responsible for lost, misdirected, incomplete, or illegible entries. Federal, state, and local tax liability and any other expenses are the sole responsibility of prize winner. Void where restricted and prohibited.
