

## Save More, Win More - Promotion Terms

### **Giveaway Administration**

This sweepstakes is being administered by Canvas Credit Union (“Canvas”).

### **How to Enter**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.**

There are two ways to enter:

1. Deposit funds into your Save More, Win More account between November 29, 2019 and November 27, 2020. Based on the amount you deposit into your Save More, Win More account, you will receive a single entry into a prize tier corresponding to the amount saved. The amount saved will be determined by the balance of your Save More, Win More account at the end of each applicable timeframe (e.g. week, month, and year) during the promotional period. No one will have an increased chance of receiving a prize by making multiple or duplicate purchases or payments, or by entering more than one time.
2. Mail your name, address, and phone number to Canvas Credit Union, Attn: Marketing Department, P.O. Box 5238, Englewood, CO 80155. Only one entry per person via mail. Each mailed entry will receive one entry into each tier.

### **Eligibility**

You must be a Canvas member in good standing (i.e. no delinquent loans or shares). Void where prohibited by law. Employees of Canvas and its partners, affiliates, and agents are not eligible to participate.

### **Prizes**

There are monthly and grand prize winners. Value of prizes ranges from \$250 to \$4,000. The prizes correspond to various ranges of savings. For example, if during the month of December 2019 you save between \$100.01 and \$500.00, then you will be entered one time in a monthly drawing to win \$750. And then, if during the month of January 2020 you save more than \$500, you would be entered one time in a monthly drawing to win \$1,500. And finally, if on November 27, 2020, you have deposited more than \$6,000 into your Save More, Win More account, you will receive one entry to win \$4,000.
